Considering the different academic resources available here under the roof of VIVA Trust, it would have been an advantage for the residential students to use these facilities without the constraints of time.
- Research prospects may be impacted by the shortage of faculty with PhDs.
- A need to improve research publication in UGC-care journals to enhance academic recognition.
- Lack of regular alumni engagement for the institution.

2. Academic bank of credits (ABC):	The initiatives taken by the institution to fulfill the requirement of Academic bank of credits as proposed in NEP 2020. Students are signed up for it. The University of Mumbai has been notified of the information. Additionally, the institution has already taken the lead and emailed the university to discuss switching to a credit-based system for course marking.

Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	University of Mumbai permits academic exams to be conducted in Marathi, Hindi, and English. English, Hindi and whenever necessary use of vernacular language is the mix medium used by faculty as per the necessity of the class. Research on Indic scripts, languages is the requirement of syllabus in which the institution contributes to the preservation and promotion of Indian art forms and languages through assignments and projects. For instance, the Department of Painting has a subject on the History of Art, delving into Indian history. Elective subjects like Lettering and Typography in Applied Art expose students to various Indian scripts. Projects such as the study of Indian historical structures contribute to the preservation of India's rich cultural heritage and ancient wisdom.
5. Focus on Outcome based education (OBE):	Outcome-Based Education is a key component of the course in the area of Applied Art and Painting since it

	focuses primarily on practical application. The assignments planned by the faculty members keeps OBE in mind, ensuring a comprehensive learning experience. Students' work improves when they receive timely feedback on their assignments. The annual art exhibition, which features student work and demonstrates the successful connection of learning outcomes with real-world applications, is a noteworthy OBE practice at the institution.
6. Distance education/online education:	The Institute is working towards encouraging students and faculty members to participate more in webinars, workshops and short courses on SWAYAM, NPTEL, MOOC and similar platforms. By encouraging students to enroll in software certificate programs, we are also aiming to prepare them for the workplace. The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

The Institution offers Applied Art and Painting academic programmes under Bachelor of Fine Art with a unique blend of creativity and real life problem solving. The curriculum places a strong emphasis on including knowledge throughout a broad spectrum, traditional wisdom to emerging contemporary concerns. In addition to information, the emphasis is on skills, application, and creative problem-solving. Most academic curricula are multi-disciplinary in character and offer specialized opportunities in expert fields. The Mumbai university-mandated program curriculum is followed at VIVA Institute of Applied Art. Furthermore, the organization has put together plans for boosting the teaching-learning process in the curriculum in the subsequent ways:

- The institute carefully plans its academic calendar to correlate with the schedule by University of Mumbai at the commencement of each academic year to offer a seamless educational experience.
- Course outcomes (CO) and programme outcomes (PO) are not clearly defined in the syllabus since the course is based on an annual pattern. According to the Applied Art syllabus, a course's evaluation is based on a marks system that includes a 20% Class work and 80% annual examination. According to the Painting syllabus, a course's evaluation is based on a marks system that includes a 40% Class work and 60% annual examination. Course outcome is followed by the focus area of each subject described in the syllabus.
- Keeping in mind the skillsets and the expertise of teaching faculty the subject division is done by the higher authority.
- Before the commencement of the academic year, annual planning of the curriculum, assignments, co-curricular activities etc. is planned by the respective class incharge with the help of fellow teachers.
- With the approval of the same by the higher authority this planning is further implemented and the work is distributed amongst class-incharge.
- The teaching staff of both departments are provided with this calendar ahead for effective assignment and lecture planning for the complete academic year well in advance.
- The hands-on workshops, expert visiting sessions are arranged for students where they get exposure to creativity. For students, practical workshops and expert visiting sessions are organized for enhance learning experience.
- Faculty members use term examinations, surprise tests and regular assignments to continuously evaluate the performance of their students. The examination process followed by the institution is strictly as per university guidelines. The results of all examinations are displayed from time to time. Every year, the students are evaluated and honored for their outstanding performance in the class work, through an annual art exhibition.
- Every student deserves to be recognized for their efforts since they are an asset to the institute.

• Co-curricular and extracurricular activities are supported and encouraged for students holistic growth. Additionally, the students also excel in fine art, performing art and literature competitions at the university levels. 2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

I. Internal Assesment

The Institute with the University of Mumbai (UoM) adheres to a strict procedure for holding annual exams for various classes and Internal Assessment (IA). An overview of the procedures for conducting, managing, and reviewing these examinations is given in this process report.

A. Formation of the Examination Committee:

The Principal serves as the committee's Chief Conductor (CC), while senior faculty members serve as Senior Supervisors (SS). This committee is essential to the evaluation procedure.

B. Term and Annual Examinations:

The academic year is split into two terms, with the annual examination taking place at the conclusion of the second term and the terminal examination taking place at the conclusion of the first term. Seating is planned and timetables are displayed well in advance.

C. Timely Result Declaration:

Two weeks following the examination, the results of the terminal examination are swiftly made public. For the benefit of students taking the upcoming yearly examination, faculty members explain the grading criteria while discussing each paper.

D. Assignment Records:

Assignment cards have been maintained for each student, detailing the submission of assignments and the marks obtained. Based on these assignment records, a total score is produced that includes 20 marks for each subject of applied art and 40 marks for each subject of painting.

II. External Assessment

A. Question Paper Handling:

One week before the exam, the examination cell receives sealed practical subject question papers from the university. The theory exam questions are made available online one hour before the examination. Password protected documents (accessed only by the principal) are downloaded while being closely watched, sealed, and sent to the SS for distribution.

B. Secure Distribution:

Junior Supervisors open the sealed packets of test questions and give them to the candidates while being witnessed by two students. Answer papers, rough sheets, and gateway sheets are obtained from the exam supervisor for each class after the examination.

C. Verification and Dispatch:

Chief Conductor (CC) and Senior Supervisors (SS) verifies all relevant information on the answer sheets. The sheets, along with the rough sheets, are sealed with college information and handed over to authorized personnel from the university for further processing.

D. Revaluation and Grievance Handling:

After result declaration, students may apply for revaluation, grievance resolution, or obtaining a Xerox copy of their answer sheets (if wish to). A grievance committee addresses student concerns, notifying them through the exam cell. Sealed answer sheets are dispatched for revaluation to the University CAP centres as per the guidelines of UoM within stipulated timelines.

E. Final Revaluation Results:

After completing the entire process, the university declares the final revaluation results. A fair and transparent examination process for students is ensured by the participation of an examination committee, respect to university policies, and a methodical processing of question papers and evaluations. The examination department's overall efficacy is further enhanced through grievance resolution procedures.
