VIAA conducts Under Graduate course of Applied Art-60, Painting-30. Institute is affiliated to University of Mumbai and approved by AICTE, New Delhi, Government of Maharashtra, and recognised by Directorate of Art (DoA) with DoA Code 1701/1702.

The curriculum and syllabus of UG are prescribed the University of Mumbai. The examination and award of degrees is done by the university.

The fee for the program is prescribed by the Fee Regulatory Authority (FRA) of the Govt. of Maharashtra.

VIAA has Vision to Socially responsive education to develop culture & innovation.
